



## Short Film Competition 2017 Terms & Conditions

---

### **1. The competition is organised by MCMUSLIM.TV**

### **2. Eligibility**

Entry to this competition is open to persons who are full time residents of the UK (including the Channel Islands and the Isle of Man) except the immediate family of the MCMUSLIM.TV executive team. Proof of age, identity and eligibility may be requested. Entry will be in three age categories on 20 August 2017 (1) under 12 (2) age 12-15 (c) over 16.

### **3. To Enter**

To register for the MCMUSLIM.TV's Short Film Competition 2017, follow the instructions found on [www.mcmuslim.tv](http://www.mcmuslim.tv)

Entry opens in Ramadhan 2017 and entry closes on 20 August 2017 at 23.59. Submissions received outside of this time frame will not be considered, so please do not wait until the last minute to upload your entry.

Entrants must submit a video via the website which will upload to YouTube. Entry is via an online entry form available at MCMUSLIM.TV. Entrants will be asked to provide their name, gender, region and their age. All submissions should be submitted in English. Other languages may be used if accompanied by English subtitles. All submissions are governed by Youtube terms and conditions.

For under 18's, an adult will be required to approve the entry and agree to these Terms and Conditions (including the MCMUSLIM.TV's use of the video submitted) on behalf of the entrant, by way of a check-box in the online form. The adult must be the child's parent or guardian. The adult must provide their own contact and personal details (not the child's). Entries not including the above will be considered void and will not be included in the competition.

The personal data provided will be used for the purposes of administering the competition. MCMUSLIM.TV will use the contact details provided by the adult to send general updates as to the progress of the competition by email.

### **4. Collaborative entries**

The entrant should have produced the majority of the video but can be assisted by others.

If any group of individuals elects to collaborate on an Entry, they are required to designate one person as the agent of the group to enter the MCMUSLIM.TV Short Film Competition, agree to these Official Rules, sign the Agreement and accept the prize on behalf of the group. Neither MCMUSLIM.TV nor any of the Project Parties are liable for any disputes between collaborators arising out of or related to the Competition. Multiple entries per person are permitted.

### **5. Production Costs**

All costs associated with the production of the Entry are solely the responsibility of the Entrants.

### **6. Competition Terms of Submission**

By submitting an Entry into this MCMUSLIM.TV Short Film Competition, each Entrant warrants and represents that the Entrant owns all rights to the Entry he/she is entering in this Competition, including, without limitation, the video or digital recording, and the performance contained in each Entry, with the exception of any assets

provided by MCMUSLIM.TV for use by Entrants in connection with this Competition. Each Entrant further warrants and represents that the Entrant has obtained permission from each person who appears in the Entry to grant the rights to the Project Parties described in these Official Rules, and will submit copies of such permissions to the Project Parties on request. By submitting an Entry, the Entrant agrees to the Official Rules, and further agrees to indemnify and hold the MCMUSLIM.TV, Project Parties and their respective affiliates, officers, directors, agents, co-branders or other partners, and any of their employees (collectively, the Project Indemnitees), harmless from any and all claims, damages, expenses, costs (including reasonable attorneys' fees) and liabilities (including settlements), brought or asserted by any third party against any of the Project Indemnitees due to or arising out of the Entrant's Entry materials in this Competition, or the Entrant's conduct during and in connection with this Competition, including but not limited to trademark, copyright, or other intellectual property rights, right of publicity, right of privacy or defamation. The Entrant agrees to release, indemnify and hold harmless MCMUSLIM.TV and the Project Parties from any and all claims that any advertising, presentation, web content or any other material subsequently produced, presented, and/or prepared by or on behalf of MCMUSLIM.TV or the Project Parties infringes on the rights of Entrant's work as contained in any Entry.

All entries must be the original work of the entrant and must not infringe the rights of any other party. MCMUSLIM.TV accepts no responsibility if entrants ignore these Terms and Conditions and entrants agree to indemnify the MCMUSLIM.TV against any claim by any third party from any breach of these Terms and Conditions.

Entries must not contain defamatory, obscene, offensive, or any other unsuitable material. Entries must be suitable to be broadcast, published or used online by the MCMUSLIM.TV for audiences of all ages, but in particular for a family audience.

Entrants retain the copyright in their entries but grant to MCMUSLIM.TV a perpetual non-exclusive royalty-free licence to publish, broadcast (across all media) and post the entry online and on any other platforms yet to be envisaged. This licence will be deemed to include all the necessary rights and permissions to enable such use by MCMUSLIM.TV, to fulfill the prizes and to complete the administration of this competition. By submitting a video the entrant agrees that MCMUSLIM.TV may at its sole discretion edit, adapt, abridge or translate the entry for the purposes listed in clause above.

## **7. Judging of Entries**

Eligible entries will be scored based on the following scoring domains used by the judges:

- Consistent with Category
- Narrative
- Performances
- Production (locations, props, costumes)
- Visual composition
- Use of audio enhancements
- Editing (transitions, titles, credits, special effects)
- Humour and entertainment

## **8. Selection of Winners**

Entries will be shortlisted according to the above criteria and judged by the Judging panel. For each age category a winner and runner-up will be selected. Winners will be notified via social media.

Winners will be informed and details posted online at [www.mcmuslim.tv](http://www.mcmuslim.tv) on Eid ul-Adha (approx. 1 Sep 2017)

Prizes will be awarded to the winners and runners-up. For those entries produced by a group of associates, the entrant who submitted the entry will receive the prize.

## **9. General Conditions**

By participating, Entrants agree to these Official Rules which are final and binding in all respects.

MCMUSLIM.TV's decision as to each stage of this competition is final. No correspondence will be entered into.

MCMUSLIM.TV reserves the right to disqualify any entry which breaches any of these Terms and Conditions, or to withhold a prize if in its opinion entries do not reach the required standard.

MCMUSLIM.TV reserves the right to amend these Terms and Conditions or cancel this competition at any stage, if deemed necessary in its opinion, or if circumstances arise outside of its control.

MCMUSLIM.TV, its sub-contractors, subsidiaries, agencies and/or any other organisation associated with this competition cannot accept any responsibility whatsoever for any technical failure or malfunction or any other problem with any server, Internet access, system or otherwise which may result in any entry being lost or not properly registered or recorded.
